The Haryana Water Resources Authority invites applications from eligible and experienced persons retired from the post of Engineer- in –Chief/Chief Engineer from the Engineering departments dealing with Water Management /Regulations/Waste water Management for engagement of 01 (one) Consultant (Treated Waste Water) for implementation of Integrated Water Resources Action Plan and advising on use of treated waste water by various industries, surface water with the following qualification and remuneration etc.:-

- 1. **Minimum Qualification**: Graduate in Civil Engineer, having served in Government of Haryana with minimum 30 years of experience in the field of Water Resources planning, management and regulation.
- **2. Experience:** Should have served on the post of Engineer-in-Chief/Chief Engineer from the Government Department dealing with Water Management / Regulation/Waste Water Management.

- 3. Period of contract: The Consultant (Treated Waste Water) may be engaged by the Authority on contractual basis initially for a period of two years which can be further extended at the sole discretion of the Authority.
