The Haryana Water Resources Authority invites application from eligible and experienced individuals for engagement as Junior Consultant (Legal) -02 Nos. (Two) purely on contract basis for the two years as per details given below:

Name of the Post: Junior consultant (Legal)-02 No.

- Must be a citizen of India ;
- Age limit: 42 years (Maximum) on the last date of submission of application. However age relaxation will be given as per the instruction issued by the Haryana Government from time to time in this regard;
- Education Qualification: Bachelor's degree in Law from a recognized University;
- Minimum Experience :At least one year as practicing advocate;
- **Candidate should be registered as an advocate with the Bar Council and candidate(s) who have passed their LLB degree from the academic year 2009-2010 onwards must have passed the AIBE-exam.**
- Adequate knowledge of drafting notification, acts,5 affidavits and all our procedures;
- Good Writing skills and communication skills in English.

DURATION OF ENGAGEMENT

- The initial term of engagement of Junior Consultant (Legal) shall be for a period of **02 (two) years** from the date of engagement and subsequent extension(s) may be given on a case to case to basis depending on requirement and performance.
- The Chairperson, HWRA can cancel the appointment or terminate the service of Junior Consultant (Legal) at any time, without providing any reason thereof.
- The Junior Consultant (Legal) can also tender resignation upon giving one month's prior notice to the Authority. The Chairman, HWRA, however, may allow deposit of one month's salary in lieu of notice period.
- The leave and other conditions will be decided by the Authority.
