Notice inviting applications for the post of Chairperson of Haryana Water Resources Authority under the Haryana Water Resources (Conservation, Regulation & Management) Authority Act, 2020.

Applications are invited for filling of one post of Chairperson of Haryana Water Resources Authority.

1. **Qualification:**

(i) The Chairperson of the Authority shall be a person of ability and integrity who has served as Additional Chief Secretary to Government Haryana with experience in dealing with management of water resources including science, technology or engineering matters connected with water resources.

Provided that preference shall be given to a person who has served as Additional Chief Secretary to Government Haryana, Irrigation & Water Resources Department.

2. **Age:**

(i) No person shall serve as Chairperson after he has attained the age of sixty-five years.

(ii) The Chairperson shall hold office for a term of three years, from the date on which he/she enters upon his/her office.

Provided that no person shall serve as Chairperson for more than two terms.

3. **Salary and Allowance:**

The salary and allowances and other terms and conditions of service of the chairperson shall be such as may be specified by the Government.

4. **Oath of Office:**

The Chairperson shall, before entering upon his/her office, make and subscribe to an oath of office and secrecy in such form and in such manner and before such authority, as may be specified by regulations.

5. **General:**

(i) The Chairperson shall be appointed by the Government on the recommendation of the Selection Committee.

(ii) Every Candidate applying for the post of Chairperson shall also submit a self-declaration stating the details of the criminal cases, vigilance enquires/cases, proceeding under the service Rules (in case of serving/retired Government Servants/PSU employees) and punishment there under, if any.

6. **Write-up:**

The applicant's needs to submit a typed write-up, not exceeding 500 words, elaborating their suitability for the post applied.

7. In case of any ambiguity the decision of the Head of the Selection Committee shall be final.
