

### **Scope of Work**

### A) Audit Functions:-

- i. Checking of cash, journal and bank vouchers.
- ii. Checking of entry of cash, journals and bank vouchers in the respective books of accounts maintained by the authority.
- iii. Checking of arithmetical accuracy of books of account maintained by the authority e.g. cash book, bank book, journal, ledgers of all subsidiary accounts.
- iv. Complete audit of financial transaction of the authority.
- v. Checking of bank reconciliation Statement.
- vi. Audit of Income & Expenditure Account and also of the Balance Sheet.

### B) Other Miscellaneous Jobs:

- (i) Filing of all kind of returns of TDS of the Authority.
- (ii) Filing of Annual return after audit of Balance Sheet.
- (iii) To apply for GST on TDS number on Form GST REG-06.
- (iv) Filing of monthly TDS GST returns on GSTR-7
- (v) Filing of any other returns under Income Tax Act and GST.
- (vi) Giving professional advice as and when required, on various technical issues, which the authority may come across in due course of time.
- (vii) Issue of utilisation certificates for receipt of grants by the authority, from time to time.
