Notice regarding Engagement of 01 (one) Senior Consultant (Legal) in Haryana Water Resources Authority, Panchkula

The Haryana Water Resources Authority has been established under the Haryana Water Resources (Conservation, Regulation and Management) Authority act, 2020.

The Haryana Water Resources Authority invites application from eligible and experienced retired Government officers for engagement as 01 (one) Senior Consultant (Legal) with the following qualification and remuneration etc.

1. **Minimum Qualification & Experience:** Retired Senior Law Officer from Haryana State Law Department/Prosecution Department, Haryana with minimum 30 years' experience in Legal field and having good health and willingness to work as Senior Consultant (Legal). Such candidate must possess strong writing and oral communication skills. Such candidate should have experience in drafting, vetting legal documents, rules, replies, applications and tendering opinion of NGT, Civil Court(s), High Court and Supreme Court.
2. **Age limit:** Age of the candidate should not be more than 62 years on the last date of application.
3. **Period of Contract:** The initial term of engagement shall be for a contractual period of 03 years (extendable further as per performance appraisal). The contract may be further extended at the sole discretion of the Authority. The contract may be terminated at any time, subject to terms & conditions to be incorporated in the contract agreement.
4. **Selection Process:** Applications will be scrutinized by a Committee constituted by the Authority and the eligible candidates shall be called for interview after scrutiny of the applications. The decision of the Chairperson, HWRA shall be final in this regard.

The Selection Committee will select the candidate on the basis of their professional ability at the time of interview. The awarding of marks/criteria for finalization of candidate is the sole discretion of the Appointing Authority. The decision of the Appointing Authority will be final in case of any dispute arises in the Selection Process. Candidate must have good command over English. Candidate must be proficient in Computers and should have good typing speed.

The selected candidate shall have no right to private practice under any circumstances. Candidate would neither have any right or claim of regular service on the basis of contractual engagement in any discipline.

The selected candidate will be liable for disciplinary provisions of Bar Council for professional misconduct. Apart from the provisions of termination of contract, provisions of prevention of Corruption Act would apply to him/her as he/she would be a public servant during the term of his/her contract.

The advertisement of engagement of Senior Consultant (Legal) should not be construed as binding on the Authority to make appointment.
