

## DETAILED ADVERTISEMENT

### Notice for inviting Applications for engagement as Consultant (Legal) in the Haryana Water Resources Authority (HWRA).

Applications are invited for engagement of one Consultant (Legal) in the HWRA as per details below:

1. **Minimum Qualification:** Degree in Bachelor of Law from recognised University or any other university or institute recognized by the Bar Council. Candidate should have passed Hindi/Sanskrit in matric standard or higher education.

Candidate should be registered an advocate with the Bar Council and candidates who have passed their LLB degree from the academic year 2009-2010 onwards must have passed the AIBE-exam.

If on verification at any stage before or after the selection, it is found that a candidate does not fulfil all or any of the eligibility condition, his/her candidature/selection shall be liable to rejection.

2. **Experience:** Candidate should have practised as an advocate or a pleader at the Bar for a period of not less than 05 (five) years. Preference shall be given to the candidates having higher qualification and experience in the required relevant field.

3. **Age Limit:** Age of the candidate should not be more than 63 years on the last date of submission of application.

4. **Selection Process:** Applications will be scrutinized by a Committee constituted by the Authority and the eligible candidates shall be called for the interview after scrutiny of the applications. The decision of the Chairperson, HWRA shall be final in this regard.

The Selection Committee will select the candidate on the basis of their professional ability at the time of interview. The awarding of marks/criteria for finalization of candidate is the sole discretion of the appointing authority. The decision of the appointing authority will be the final in respect of the matter in case of any dispute arises in the selection process.

The selected candidate shall have no right to private practice under any circumstances. Candidate would neither have any right or claim of regular service on the basis of contractual engagement in any discipline.

The selected candidate will be liable for disciplinary provisions or Bar Council for professional misconduct. Apart from the provisions of termination of the contract, provisions of prevention of Corruption Act would apply to him/her as he/she would be a public servant during the term of his/ her contract.

The advertisement of engagement of Consultant (Legal) should not be constituted as binding on the authority to make appointment.

**5. Period of contract:** The selected candidates shall enter into a contract agreement with the Authority at the time of appointment. The Consultant (Legal) may be engaged by the Authority on contractual basis initially for a period of two years or till the regular incumbent joins or until further orders whichever is earlier. The contract may be further extended at the sole discretion of the Authority. The contract may be terminated at any time, subject to the terms & conditions to be incorporated in the contract agreement.

**6. Remuneration:** The Consultant (Legal) will be paid remuneration Rs. 67,700/-. No other allowances shall be admissible.

The Candidate(s) shall submit their application in the attached proforma alongwith supporting documents and a typed write-up, not exceeding 500 words, elaborating their suitability as Consultant (Legal), during working hours in the Office of Chief Executive Officer, Haryana Water Resources Authority, 3<sup>rd</sup> Floor, Rear Building, HSVP HQ, Sector 06, Panchkula 134109 by 30th November, 2021 till 05:00 PM. Applications received after the last date shall not be entertained.
