

## DETAILED ADVERTISEMENT

### Notice for inviting Applications for engagement as Junior Consultant (Water Resources) in the Haryana Water Resources Authority (HWRA).

Applications are invited for engagement of 02 Nos. (Two) Junior Consultants (Water Resources) in the HWRA as per details below:

**1. Minimum Qualification:** M.Sc./M Tech in Geology/ Applied Geology from a recognized University. Candidate should have passed Hindi/Sanskrit in matric standard or higher education.

If on verification at any stage before or after the selection, it is found that a candidate does not fulfil all or any of the eligibility condition, his/her candidature/selection shall be liable to rejection.

**2. Experience:** Preference shall be given to the candidate having experience in any sector related to water resources/ Ground Water, Rainwater Harvesting/Treated Waste Water/ Recharge Techniques including their designing.

**3. Selection Process:** Applications will be scrutinized by a Committee constituted by the Authority. The decision of the Chairperson, HWRA shall be final in this regard.

The Selection Committee will select the candidate on the basis of their professional ability at the time of interview. The awarding of marks/criteria for finalization of candidate is the sole discretion of the appointing authority. The decision of the appointing authority will be the final in respect of the matter in case of any dispute arises in the selection process.

Candidate would neither have any right or claim of regular service on the basis of contractual engagement in any discipline.

The selected candidate will be liable for disciplinary provisions for misconduct. Apart from the provisions of termination of the contract, provisions of prevention of Corruption Act would apply to him/her as he/she would be a public servant during the term of his/ her contract.

The advertisement of engagement of Junior Consultant (Water Resources) should not be constituted as binding on the authority to make appointment.

**4. Period of contract:** The selected candidates shall enter into a contract agreement with the Authority at the time of appointment. The Junior Consultant (Water Resource) may be engaged by the Authority on contractual basis initially for a period of one year or until further orders whichever is earlier. The contract may be further extended at the sole discretion of the Authority. The contract may be terminated at any time, subject to the

terms & conditions to be incorporated in the contract agreement. Subsequent extension(s), if any, shall be decided on case to case basis depending upon the requirement and performance.

6. **Remuneration:** The Junior Consultant (Water Resources) shall be paid fixed emoluments of Rs.25,000/- per month and can be increased annually on performance basis at the discretion of the Authority.
